**Are Human Rights Funders Prepared?**

Tuberculosis patients are locked up in South Africa. SARS information is censored in China. Laws criminalizing HIV transmission are sweeping Africa amidst calls for mandatory HIV tests. As governments respond to health emergencies with coercive measures, funders have largely ignored one of the most important emerging threats to human rights. Like the "war on terror," disease control can curtail basic rights of due process, information, and equality. Increasingly, human rights groups are combating these abuses and partnering with health experts on pragmatic, rights-based solutions. This panel will feature leading experts on these issues and present concrete ways that IHRFG members can respond.

**Detention of Terror Suspects**

Does the threat of terrorism justify detention without charge? How can we protect security and human rights? The debate on the future of Guantanamo and the fate of its detainees has begun to raise the question of whether a new form of preventative detention is required for terrorist suspects. A growing number of voices contend it is, arguing some detainees cannot be criminally prosecuted without compromising

intelligence and are too dangerous to be released. In the wake of the US Supreme Court's recent ruling on detainee rights (*Boumediene v. Bush*), leading advocates will discuss the key arguments in this looming national debate about closing Guantanamo and handling terrorist suspects.

United Nations human rights institutions are inherently representative of the policies of the member states. The UN will become more progressive and effective in promoting human rights only if more member states pursue positive policies in UN fora.

***The Human Rights Framework –  
Is it always the most strategic?***

Funders working on manifold issues in Brazil, Russia, and India, across Africa and the Arab World, and internationally on women's issues, will debate the advantages and disadvantages of using a human rights framework in practicing social justice philanthropy. Can human rights language make the strongest case for reversing centuries of structural discrimination against Dalits in India? What is the public perception of human rights issues in Brazil? What does it take to motivate the business sector and ordinary citizens to support grassroots projects that advance human rights and social justice in Russia? What does it mean to build a legitimate human rights funding movement that is both sustainable and accountable?
